The BVP Grant Program is a critical resource for state and local jurisdictions. Over the past decade, this vital program has enabled the protection of over one million officers. However, while many officers are protected by bullet-resistant armor, an alarming number of officers, many in small departments across the United States, are not afforded this same protection due to local budget constraints. <u>NAPO believes this legislation is essential to assist state and local law</u> <u>enforcement efforts to purchase bullet</u> <u>resistant vests for their officers. NAPO worked closely with</u> <u>senior staffers for the bill's sponsors,</u> <u>Senate Judiciary Committee Ranking</u> <u>Member Patrick Leahy (R-VT) and</u> <u>Senator Lindsey Graham (R-SC), to</u> <u>pass this bill through the Senate. We</u> will continue to work with fellow stakeholders to garner support to pass this legislation during the 114 th <u>Congress.</u>
